nformation we collect about you

We may collect and store the following types of information about you when you visit our ite or by corresponding with us (for example, by e-mail). This includes information you provide when registering to use our sites or sharing any data via our social media unctions. The information given to us may include:

- information in relation to your purchase of our artwork, antiques or use of our ervices.

How we collect information about you

You may give us your information by [filling in forms on our site or by corresponding with us by post, phone, email, on social media or otherwise]. This includes information you provide when you:

- visit us at art and antiques fairs;
- your purchase of any artwork or antique; and

Legal basis for processing

Dur processing of your personal information is necessary (i) for the purposes of legitimate nterests pursued by us; (ii) in order to comply with a legal obligation to which we are subject; or (iii) for the performance of contracts to which you will be a party to and in order to take steps at your request prior to you entering into those contracts.

n relation to any processing of special categories of personal data, we will generally rely on obtaining specific consent from you at the time unless there is otherwise a legal equirement for us to process such information.

Legitimate interests

Where our processing is based on the legitimate interest grounds described above, those egitimate interests are:

- collecting personal information to provide you with a smooth and efficient client experience;
- running our business;
- to make sure you receive updated information on our activities;

- to provide the services you have requested; and
- [for our own marketing, research and development.]

How we use your information

We use your information to:

- provide information about our antiques / artworks / works of art and services to you.
- keep you informed about antiques / artworks / works of art, artists and events that we hink you may find interesting.
- carry out our obligations arising from any agreements entered into between you and is.
- communicate with you.
- comply with legal and regulatory obligations; and
- for security and to check your identity.

Vill we share your information with third parties?

Except as expressly set out in this policy we will not sell, distribute or lease your personal information to third parties unless we have your permission or are required by aw to do so.

We may also share your personal information with:

law enforcement agencies, other governmental agencies or third parties if we are equired by law to do so.

Your rights

At any time, you have the right:

- to request access to or a copy of any personal data which we hold about you;
- to rectification of your personal data, if you consider that the information we are solding is inaccurate;
- to ask us to erase your personal data, if you consider that we do not have the right to rold it;
- to withdraw consent to our processing of your personal data (to the extent such processing is based on previously obtained consent);
- to ask us to stop or start sending you marketing messages as described below in the narketing section;
- to restrict processing of your personal data;
- to data portability (moving some of your personal data elsewhere) in certain circumstances;
- to object to your personal data being processed in certain circumstances; and
- to not be subject to a decision based on automated processing and to have safeguards out in place if you are being profiled based on your personal data.

Any request from you for access to or a copy of your personal data must be in writing and ve will endeavour to respond within a reasonable period and in any event within one nonth in compliance with data protection legislation. We will comply with our legal obligations as regards your rights as a data subject.

We will action any opt out request from you without delay.

How long will we keep your information?

We will only keep the information we collect about you for as long as required for the purposes set out above or as required to comply with any legal obligations to which we are ubject. This will involve us periodically reviewing our files to check that information is accurate, up-to-date and still required.

Where we are permitted to send you direct marketing communications we may retain your contact information necessary for this purpose, for as long as you do not unsubscribe from eceiving the same from us. If you opt out from marketing, we will retain your nformation to enable us to respect your wishes to not be contacted for marketing purposes.

Security and storage of your information

We are committed to ensuring that your information is secure. In order to prevent inauthorised access or disclosure, we have put in place suitable physical, electronic and nanagerial procedures to safeguard and secure the information we collect from you.

How we use cookies

What are cookies?

A cookie is a small file which asks permission to be placed on your computer's hard drive. Ince you agree, the file is added and the cookie helps analyse web traffic or lets you know when you visit a particular site.

A cookie in no way gives us access to your computer or any information about you, other han the data you choose to share with us.
